


Mina do Barroso Lithium Project – Community Newsletter December 2018 Edition

Savannah Information Centre – Covas do Barroso

Savannah has been preparing an Information Centre in Covas do Barroso to be a focal point for the company and t its exploration and development plans for the Barroso Lithium project.

It is expected that the Information Centre will be ready for use soon with the centre having new floors and lighting installed. It is intended that the Centre will be open for selected periods during the week and weekend when people can visit and enquire about the project and current activities. Once the Centre is open details on the opening hours will be provided.

Field Activities

Exploration

Exploration drilling has continued during November with drilling being undertaken at Grandão, Reservatório, NOA and Pinheiro for the collection of further information to better understand the properties of the mineralisation.

Exploration activities will slow down over the Christmas holiday with a three-week break in drilling operations.

Mining

Mining operation continued at the NOA open pit with a small blast being completed to access further pegmatite material which is sold to local ceramic producers.

Environmental Assessments

As part of the ongoing environmental impact assessment there have been several programmes of data collection to determine the characteristics of the environment around the proposed mine developments.

Water

Water quality samples were collected from the rivers and stream in the area to form a base line of water quality to which future samples can be compared against. Specific water monitoring holes are being completed at Grandão and NOA to determine water flow. The drilling of the water holes will be used to assess the impact, if any, on the surrounding ground water levels.

Soil

In areas of the of the proposed development plan where the removal of surface soil will be required, samples of soil have been collected to determine what impact, if any, their removal will have on the surrounding areas.







Noise and Dust

Surveys were completed in the area of proposed activities to establish what extent existing activities in the area have on noise and dust levels in the environment. This information will be used as a baseline for future monitoring.

Mine Plan

Savannah Resources is now finalising a proposal of the Mine Plan, to present and discuss with the national and local authorities, community and other stakeholders. This Mine Plan will answer to several existing questions, such as the proposed location of all the mine key locations (pits, industrial area, roads, etc.) and links to existing roads, if the Mine is developed. One of the main goals is to have the minimum impact possible in the population, environment and existing infrastructures.
