Message from CEO

Dear Members of the Community,

I would like to write to you at this difficult time and keep you up to date with news from Savannah.

Firstly, I hope that each of you, and your family and friends are weathering the very difficult circumstances all of us are living through at the moment and that each of you are well and healthy.

We are very pleased to see that Portugal has been fortunate in that it has not suffered as badly as some other European countries. The geographical location of the Boticas region has also helped it in having a lower level of infections in comparison to other parts of Portugal.

At Savannah we took early steps to protect both our staff and the communities with which we work.

Savannah has taken the following actions across its operations in response to the current health emergency:

- Temporarily closed all offices and arranged for all staff to work remotely
- Temporarily suspended all field activities
- Suspended all non-essential travel
- Rearranged meetings to take place via telephone, video conferencing or online where possible.

These actions have helped ensure that, to date, none of Savannah's employees have shown symptoms consistent with the Coronavirus.


What this has meant is that field activities in and around Covas do Barroso are currently suspended, and a resumption will depend upon government directions and consultation with local leaders. Our office in Boticas is closed and our staff are all working from home. The Information Centre in Covas do Barroso is also closed.

We have kept in close contact with both the Mayor of Boticas, Fernando Queiroga, and of Covas do Barroso, Lúcia Martins Dias Mó, and have offered each any assistance that we might be able to provide. We have been impressed with the measures that both Mayors are undertaking to protect the health and welfare of their populations.

In the meantime, we continue our work on the completion of the Environmental Impact Assessment and the Mine Plan and we hope to be able to file this shortly with Agência Portuguesa do Ambiente (APA). Once APA has completed a preliminary review the EIA will be made available and the opportunity for public comment will open up.

The program of involvement with landowners has been maintained, with some limitations in face of the current restrictions, having continued contacts with landowners through our local real estate consultant. At the beginning of March, field work was carried out to clean the boundaries of the land under negotiation, at the request of the owners. A topographic survey of these lands was also carried out, in order to ensure that all legal procedures are complied with for the acquisition of the plots in question.

Savannah continues to develop a benefit sharing program so that we can present and discuss with the Mayor of Boticas, Community, Baldios CdB, CdB Parish Council and all neighboring areas the benefits that we intend to share.

In addition to this sharing of benefits, we are taking into account all necessary mitigation/elimination measures for possible impacts, such as compensatory measures.

Wish that everyone can stay healthy and safe, hoping to see you all soon.
